Certisecure is an independent third-party certification scheme in support of the 'Secured by Design' initiative that offers enforcement authorities, architects, specifiers, and building owners a high level of confidence that products offer an enhanced level of security, whilst at the same time maintaining fit for purpose



Certifire is an independent third-party fire product certification scheme that assures performance, quality, reliability, and traceability of products and systems. The Certifire brand is recognized by regulatory authorities worldwide as an international mark of fire safety across fire products. Certifire helps give end-user confidence with regards to the stated performance of the product, providing an informed choice when purchasing or selecting the product.

Secured by Design (SBD) operates an accreditation scheme on behalf of the UK police for products or services that have met recognised security standards. Such products or services must be capable of deterring or preventing crime and are known as being of a 'Police Preferred Specification'. Our range of flat entrance doorsets are designed to meet this specification.



Forest Stewardship Council (FSC) certification ensures that products are sourced and manufactured from responsibly managed forests. FSC has established a certification system that ultimately ensures sustainable management of the world's forests. JELD-WEN doors are FSC certified.



PEFC endorses national forest certification systems that have been developed through multi-stakeholder processes and tailored to local priorities and conditions. They work to protect our forests by promoting sustainable forest management through certifications. JELD-WEN doors hold a PEFC certification



The BWF Fire Door Alliance is operated and managed by the British Woodworking Federation (BWF). It is a scheme that champions third-party certification of fire doors and doorsets. Comprising of manufacturers of timber fire doors and fire doorsets, processors, distributors and suppliers of integral components. JELD-WEN as a member shares the vision by ensuring that every fire door or fire doorset manufactured and sold in the UK meets required standards throughout its service life.





Approved Document Q refers to the security of homes and dwellings. It is intended to make sure that all entry points to a property, i.e. windows and doors, provide a certain level of security. Any door that is marketed as compliant with Approved Document Part Q will have been tested to ensure it meets the requirements of **PAS 24**.



**ISO 14001:2015** – ISO 14001 is an internationally agreed and recognised standard for Environmental Management Systems. It requires organisations to assess environmental issues relevant to their operations, such as waste management, resource use and efficiency, enabling them to reduce cost, and wastage and be proactive towards a green future. JELD-WEN ISO 14001 certificate allows us to reduce our environmental impact, also validates our compliance with current environmental legislation, as well as adopt future regulations.
